## Czech Republic, Nová Paka, 5. – 7. July 2024

This document contains the particularities of the Competition and is based on the currently valid Appendices to the International Sporting Code («the Code») and on the newest version of the Sporting Regulations for Competitions of the FIA European Autocross. For all articles not specified in this document, the Sporting Regulations for Competitions of the FIA European Autocross Championships.

#### **III. GENERAL CONDITIONS**

The Support Race: International Touring Autocross Special and Group "H"

- Not counting into any championship
- Vehicles TAX 4x4 or 4x2
- The safety belts must comply with one of FIA Standards and must have valid life time period
- The seats must comply with one of FIA Standards and must have valid life time period
- Tires of your own choice
- Fuel of your own choice according Art. 252.9 Appendix J ISC FIA
- Driver's safety equipment must comply with one of the FIA Standards
- The vehicle must have a sporting licence from the corresponding ASN.
- Valid 2024 driver's licence issued by ASN (national or international)
- Starting permission for start abroad (for foreign drivers)
- The race will be in accordance with the FIA European Championship Sporting Code
- The organizer will issue starting numbers to the drivers starting with "4"
- Vehicles from the Finals will NO LONGER be entering the PARC-FERME

#### a) DESCRIPTION OF THE CIRCUIT

Place: Nová Paka (CZE)

Location: 130 km northeaster from Prague - route E 65 or E 68

Point GPS: 50°29'20.47"N, 15°32'17.00"E

#### b) ENTRY FORMS - ENTRIES

Anybody wishing to take part in the Competition has to send the Entry Form to the e-mail: autoklubnp@seznam.cz

The maximum number of starters will be 30.

The system for booking of parking places in paddock will start on 10.06.2024 on website www.autoklubnp.cz

## c) ENTRY FEES

The entry fee is: 200 € Closing date for entries: 02.07.2024

As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, has to apologise giving the reason as soon as possible.

#### **d)** Entry fees may be refunded only:

- to candidates who are not accepted,
- in the case of the Competition not taking place

#### **IV. INSURANCE**

According the ASN's insurance cover for national races.

#### a) Insurance coverage of the organizer

The ACCR concluded a frame insurance contract No. C550012623 with "Allianz Pojišťovna, a.s." through the company PLATINUM Consulting s.r.o. The insurance covers damage caused to other people on the Event to the sum of CZK 50.000.000

#### **b)** Insurance of competitors and drivers

A part of the frame insurance contract, is the insurance of damage caused to other parties by the drivers and their vehicles. The insurance does not cover damage to other drivers or their vehicles. The insurance limit for one participant is 50 000 000 CZK with co-participation of 5000 CZK for one insurance event. This means that damage up to 5000 CZK is not covered and damage above this limit is covered in full amount.

c) Each driver is obliged to have his own injury insurance, which he must, upon request, present at the administrative checking. The insurance of foreign drivers must include the coverage of costs for medical treatment in the Czech Republic.

#### V. PRIZES AND CUPS

The organiser will provide and give cups to all finalists (position 1-10).

The prize money will be awarded in Euros. The given sum is after tax deduction.

With less than 15 Drivers in the Touring Autocross, the prize money will be reduced by 50 %.
